**WITNESSED ATTESTATION OF CONSENT, ELIGIBILITY, AND RELEASE OF CLAIMS**

By signing below and accepting and accepting any prize to be awarded on behalf of the nominee by Kansas City Power and Light Company (“KCP&L”), KCP&L Greater Missouri Operations Company (“GMO”), and the Kansas City Chiefs Football Club, Inc.
